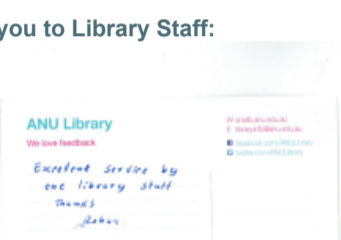

ANDS/RDS/Nectar

Update on developing a 'Australian Research Data Cloud' for National Researchers. The 2016 National Research Infrastructure Roadmap (2016 Roadmap) outlines national research infrastructure required over the coming decade so that Australia's world class research system continues to improve productivity, create jobs, lift economic growth and support a healthy environment. To progress the Digital Data and eResearch Platforms focus area, the Department of Education and Training (the Department) commissioned a review into the development of a National Research Data Cloud (NRDC) National Collaborative Research Infrastructure Strategy (NCRIS) project to meet the research sector's eResearch needs into the future, including integrating and/or refocusing existing ANDS, Nectar and RDS activities. The Reference Group has provided the Department with advice and recommendations on a Future Design for the NRDC. The Future Design Advice is intended to keep Australia at the forefront of global digital infrastructure development and delivery for research, transform the way that data-intensive research is conducted, and facilitate translation between the research and public and private sectors. The Department has accepted the Future Design Advice as one of the key pillars which will underpin the implementation of the NRDC. The high-level and strategic advice it provides allows the flexibility that is critical given key decisions are still to be made, particularly in relation to the Australian Government's Research Infrastructure Investment Plan (RIIP). With the Future Design Advice in mind, the Reference Group has progressed to developing a transition plan aimed at supporting a seamless transition to the NRDC, which is to commence on 1 July 2018, without disrupting the research that relies on the existing ANDS, Nectar and RDS projects. The Reference Group is expected to complete its work by the end of the March 2018. As well as other matters identified in the transition plan, the transition will see the NRDC take up existing ANDS, Nectar and RDS activities. The Department has agreed to the extension and appropriate funding of these activities until 30 June 2019, providing a key underpinning for the seamless transition. Other actions that lead to the establishment of the NRDC from April 2018 will be conducted in line with existing NCRIS Guidelines and funding, and subsequently on the Department's ability to act in the context of the RIIP.

- The University of Oxford academic community wishes to ensure the widest possible access to its world-class research. The value and utility of research outputs increases the more broadly they are available to be considered and used by others. A core component of this is open access (OA).
- The University continues to support the academic freedom of its authors (academics, researchers, staff and students) to publish where they choose.

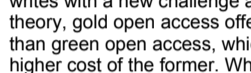
