

### ANU Press and Open Access Publishing

**Duncan Ivison on OA.** As the open access movement shifts its focus from sharing publications to the "tougher" question of sharing data, universities must shift the focus of their reward systems from publications to other modes of knowledge creation, according to the signatories to a new pact. University of Sydney deputy vice-chancellor Duncan Ivison said a radical change in mindset about the value of academic contributions to research was needed to achieve an equally radical "opening up" of the scientific method.

**UKRI wants monographs to be open access by 2024.** Jack Grove reports on new draft proposals published on 13 February, UK Research and Innovation that require all scholarly monographs, book chapters and edited collections that acknowledge its funding to be made open access from January 2024 within 12 months of publication, unless a contract has been signed before this date that prevents adherence to the policy. The consultation, which has been launched as part of UKRI's ongoing open access review, will close on 17 April. UKRI will use responses to inform its final policy, which it intends to announce in 2020. Yes this has been announced before, but this heralds a new round of consultation on the detail. Expect opposition from various groups.


**150K animal and plant illustrations available.** The [Biodiversity Heritage Library's Flickr site](#) offers more than 150,000 pages of literature, some of which date back to the 15th century. Some 158,000 illustrations are available for [free download](#) in high-resolution files. Among the collections is a digital copy of Joseph Wolf's two-volume *Zoological Sketches* containing about 100 lithographs depicting wild animals housed in London's Regent's Park. Other diverse works range from a [watercolor project](#) detailing flowers indigenous to the Hawaiian islands, to a [guide for do-it-yourself taxidermy](#) with illustrated instructions published in 1833.

**Increasing Visibility of Open Access Materials in a Library Catalog: Case Study at a Large Academic Research Library.** This report on the Penn State's catalog: addresses the issue of visibility. Some of the issues it raises:

- whether to mark as OA items that are free to read but don't bear an open license (we did not),
- where in the MARC record to look for indications that an item might be OA, and the need to create MARC records for OA publications from library publishing programs.

**OA:switchboard.** The OA Switchboard "aims to leverage the benefits that a central payment intermediary can provide while avoiding challenges and risks that could be associated. The main function of the OA Switchboard will be to enable participating publishers, academic institutions and research funding organizations to send and receive a defined set of messages relating to the publication of open access research outputs. ### Open Research

**Journal ranking.** A new ranking system for academic journals measuring their commitment to research transparency will be launched next month – providing an alternative to journal impact scores. Under a new initiative from the Center for Open Science, based in Charlottesville, Va., more than 300 scholarly titles in psychology, education and biomedical science will be assessed on 10 measures related to transparency, with their overall result for each category published in a publicly available table. The center aims to provide scores for about 1,000 journals within six to eight months of the site's launch in early February.

### Keeping up to date

**ALIA LIS Education, Skills and Employment Trend Report 2019.** ALIA has published its sixth annual ALIA LIS Education, Skills and Employment trend report. The 2019 edition reveals a 10-year decline in the number of institutions accredited by ALIA, from 31 in 2010 to 23 in 2020 (predicted), and in the number of LIS courses offered, down from 50 in 2010 to 34 in 2020 (predicted). **Three states sue US Archivist to add ERA to Constitution.** The attorneys general for the last three states to ratify the Equal Rights Amendment filed a lawsuit in federal court on January 30 arguing that the amendment must be added to the US Constitution. The lawsuit by Virginia Attorney General Mark R. Herring, Illinois Attorney General Kwame Raouf, and Nevada Attorney General Aaron Ford challenges a Justice Department memo earlier this month that said the US Archivist, who certifies the ratification of amendments, should not do so because the congressional deadline for ratification expired in 1982.

**Born-Digital File Format Standards.** The National Archives of Australia is seeking feedback from Australian Government agencies on the development of Born-Digital File Format Standards. The standard applies to born-digital files created by agencies and specifies which formats are to be used to ensure that government information is preserved, accessible and interchangeable in line with the National Archives' Digital Continuity Policy. The standards will replace the current Long-Term File Format Guidelines that are currently published on the National Archives' website.
