Presentations are often accompanied by a tour of the Archives storage repository and hands-on displays. Students see the ledgers, photographs, files and field notes held in the Archives. New student load process for Sierra. Many thanks to Mark and ITS staff. Mark has advised that he completed user acceptance testing and the Connecting ANU team completed system integration testing for the new student load process. The deployment would happen in about a week, with the exact date to be determined. In this process, Sierra API will receive data combined from the student and staff systems whenever a student enrolls at ANU and whenever their status changes, including their co-existing staff (HR) status. The rules are complex and this is the first time HR and student records have exchanged data like this. A follow up batch load will occur the following day. A follow up batch load will occur the following day to insert barcodes into the Sierra student records. This has also been thoroughly tested.

- The Australian Libraries Copyright Committee met this week – the AGM and the committee meeting were held on Tuesday
The ACCC is seeking views to inform its work on developing a new draft mandatory code that will address bargaining power imbalances between Australia's news media businesses and Google and Facebook. A concepts paper was released this week setting out a range of issues for which the ACCC is seeking feedback and information; including what should be included in the draft bargaining code, how particular issues should be addressed, and how the code should operate. It brings forward recommendations from the digital platforms inquiry
UC Berkeley Library has released Responsible Access Workflows as an adaptable way for U.S. cultural heritage institutions to navigate these hurdles to facilitate digitization of special collections including copyright, contracts, privacy, and ethics. The four workflows can be applied in any order

New resources for keeping universities safer online. Universities Australia released a terrifically helpful resource in collaboration with eSafety. the Toolkit for Universities, a collaboration includes 14 individual resources and covers a range of topics for students, academics and institutions, including: Online Safety 101; tips for supporting staff wellbeing; guides for responding to cyber abuse; and supporting students and staff using online platforms, including videoconferencing. ANU Press and Open Access Publishing

Discipline-specific Open Access Publishing Practices and Barriers to Change: An Evidence-Based Review.

This study investigates the underlying mechanisms that cause disciplines to vary in their OA publishing practices. We aimed to answer two questions: First, how do different disciplines adopt and shape OA publishing practices? Second, what discipline-specific barriers to and potentials for OA can be identified? Over the last three decades, scholarly publishing has experienced a shift from "closed" access to OA as the proportion of scholarly literature that is openly accessible has increased continuously. Historically grown publishing practices differ in terms of their compatibility with OA, which is the reason why OA can be assumed to be a natural continuation of publishing cultures in some disciplines, whereas in other disciplines, the implementation of OA faces major barriers and would require a change of research culture. >> read more

Research4Life Landscape and Situation Analysis. This report is organised around four main sections. Section 2 discusses global trends that are, or are likely to be, consequential for international development; it provides the broader context for the trends discussed in the following sections. Section 3 reviews the main trends shaping research funding, research production and research dissemination in low-and-middle-income countries. Section 4 discusses the most relevant trends in scholarly communication and how these affect the business model of publishing and the user experience of researchers, as both authors and readers.
