# Work under the "return to work" program

An update on issues during this time to help us all work across the campus while operation in the time of COVID 19 continues to occur.

**Fogging:** The JB Chifley, WK Hancock, RG Menzies and Law libraries are included in the fogging program. The fogging happens generally early in the morning – within the areas that have been identified by branch managers. A very big thank you for the extensive work being done by Heather Jenks to make sure that all the cleaning activities occur and we are all informed.

**Cleaning:** A reminder that you can see the additional cleaning staff around – they are generally wearing the pink tabards and are doing a marvellous job on the high touch areas.

WHS weekly checklist: Heather organises and follows up on the weekly reporting that is required from the Division to HR through the COVID 19 period. Thank you Heather.

WHS inspection: A Work Environment Group (WEG) member with assistance from Heather Jenks conducted a COVID 19 inspection of the JB Chifley Library this week. Meredith attended for some of the audit. A small number of recommendations have been made. Thank you the Heather and Chifley staff for your support in implementing them. Hancock has been proposed for the next inspection next week.

### ANU Press and Open Access Publishing

SpringerOpen 2019 – 2020. Angi Shi & Heather Morrison have analysed the Springer Open titles – finding that 307 SpringerOpen titles for which they have data on journals that were fully open at some point from 2010 to the present were studied, with a primary focus on pricing and status changes. Of the 307 titles, 226 are active, fully open access and are still published by SpringerOpen, 40 have ceased publication, 19 were transferred to another publisher, and 18 journals that were formerly open access are now hybrid. 6 of these journals transitioned from free to hybrid in the past year. Of the 226 active journals published by SpringerOpen, 51% charge APCs. The average APC is 1,233 EUR, an increase of 3% over the 2019 average. 46.5% of the 101 journals for which we have 2019 and 2020 data did not change in price; 13.9% decreased in price; and 39.6% increased in price. The extent of change in price was substantial, ranging from a 50% price drop to a 94% price increase. .>> read more

The regular WHS annual audits will commence next week.

**Security:** Lucas has provided the following advice – and thanks to him and Security staff who are doing a marvellous job.

- The new (current) 24 hour Kambri guard roster which encompasses the Chifley and Hancock Library guard hours is being trialled over the next two months prior to returning for Semester Two.
- In the current mode they are planning hourly checks of Chifley and Hancock Libraries (10-15 minutes per check per library per hour, 24 hours, 7 days a week). If they maintain this in Semester Two then the day/afternoon checks (8:00am – 10:00pm) will reduce to every two hours due to greater the demands at presence and library staff presence.
- In addition during the evenings (8:00pm-8:00am) and weekends 24 hours the guard will base themselves in the Chifley Library. This will create a "Security Help Point" for general after hours enquiries/issues.
- The approach will be reviewed in July).
- Other libraries (Menzies, Law and SOM/SOA) will be added into the daytime patrols of the zone guards to every two hours during their operating hours

# Survey of research culture in Australian NHMRC-funded

institutions. Key messages Institutional research culture is critical to the conduct of high quality research. Many institutions already have processes and initiatives in place to support the conduct of high quality research. As part of NHMRC's Research Quality Strategy, a survey was conducted to gain insight into the research culture in Australian NHMRC-funded institutions. Views were sought from researchers (senior, midcareer and junior), research students (masters and PhD students), institutional representatives and ethics committee members. The results were mixed about whether the research culture in NHMRC-funded institutions is supportive of responsible research practices. Participants reported on both positive and negative aspects of their research environment, barriers and enablers to excellence in research quality, behaviours that affect research quality, and opportunities for change and innovation. >> read more
