

Semester 2. Next week semester 2 commences and we will see some changes, based on the University's current planning. You can find the overarching framework here.




From Return to Campus Taskforce. Please be advised that Facilities & Services continue to provide Whiteley Industries Viraclean (listed on link below) as disinfectant to local areas. It is a local area responsibility to ensure that your stock is maintained by contacting F&S as required. This link lists the current disinfectants on the Australian Register of Therapeutic Goods (ARTG) for use against COVID-19. It is important to note that claims that a disinfectant has an effect against any virus must be expressly permitted by the TGA before being used in consumer advertising (including on the label).

OCLC COVID-19 REALM project. OCLC's project with Battelle has provided very useful information - the latest test results cover (1) Braille paper pages* (2) Glossy paper pages** (3) Magazine pages** (4) Children's board book** (5) Archival folders***.

Public Libraries in Europe and COVID-19. The National Authorities on Public Libraries in Europe (NAPLE) have released updated findings from 22 European countries regarding the way that COVID-19 affected public library services up until July 2020. The new report summarises how public libraries responded to the challenge of the virus with a focus on re-opening strategies and approaches; quarantining of books and other health and safety measures; and other issues that have emerged over the last two months.

Library chat bot. Some interesting use in its first week:





Privacy/data protection. EDPS Statement following the Court of Justice ruling in Case C-311/18 Data Protection Commissioner v Facebook Ireland Ltd and Maximilian Schrems ("Schrems II"). EDPS welcomes "that the Court of Justice of the European Union, in its landmark Grand Chamber judgment of 16 July 2020, reaffirmed the importance of maintaining a high level of protection of personal data transferred from the European Union to third countries...EDPS trusts that the United States will deploy all possible efforts and means to move towards a comprehensive data protection and privacy legal framework, which genuinely meets the requirements for adequate safeguards reaffirmed by the Court".

HISTORY. Some insights into perceptions about libraries from the past.

You are aware that the Public Library is now opened for general use. It is not, however, available to a very large portion of those who would most appreciate its advantages. I mean the young gentlemen engaged in the public services, the banks, and the merchants' counting houses, as it is closed in the evening, which is the only time this numerous class of readers can find time leisure to avail themselves of its advantages. It is, however, understood that it will be opened in the evening, as soon arrangements are made to have it lighted with gas. This will be a great improvement, by enlarging the sphere of its usefulness, and affording accommodation to a class of persons, whom it is of the greatest importance to remove from the temptations of far less respectable recreations. Selling reproductions from digitised library collections. This week an academic intended a reproduction of a library item that had been digitised which was being sold online. There are a large number of reproductions being sold by the bookseller - from the ANU Library, Kyoto University's Amabe digitisation project and Harvard Yenching digitised items as well as many others from another library. This raises interesting questions of whether those purchasing the materials understand that they are reproductions, the nature of opening up knowledge through commercial resellers, digital rights and the nature of commercialisation of content beyond the traditional means of selling and reselling. Reminder regarding personal electrical appliances

- Do not use personal electrical appliances/equipment unless they are first inspected, tested and tagged, deemed safe for use and are still in the valid period of electrical testing; Do not use an electrical appliance/equipment/plant/item if it is damaged in any way; Do not use an electrical appliance/equipment/plant/item if it is discoloured; Do not use an electrical appliance/equipment/plant/item if it is overdue for electrical testing and tagging; Do not use any item that has been RED TAGGED and do not remove red tags; Do not use a double adaptor. Only use power boards with an overload protection; Do not use any travel adaptors. Australian leads are available to swap out international plugs. Do not attempt to modify any electrical equipment; AND All staff and students are required to conduct visual inspections before each use of any electrical appliance/equipment/plant/item whether owned by the University or by themselves;

NOTE: 90% of items that fail their electrical test, fail on the initial visual inspection. If the item looks damaged or with defects or if there are any concerns, STOP and get it checked out with your Test and Tag Officer

ANU Press and Open Access Publishing

cOAlitionS - new controversy about author rights. T

Rick Anderson reviews the latest Plan S announcement and comments "Though billed misleadingly by cOAlition S as a plan "to safeguard researchers' intellectual ownership rights," both the purpose and the effect of this expanded strategy remain - as has always been the case with Plan S publishing requirements - to take intellectual ownership rights away from authors, transferring them to the general public (rather than to publishers)". -> read more

European Research Council calls for OA plans to respect researchers needs. The ERC Scientific Council is committed to implementing full and immediate Open Access and continues to support the principles underlying Plan S. Members of the ERC Scientific Council are participating constructively in various activities aimed at making Open Access a reality. However, during the past six months, the ERC Scientific Council has intensified its internal debate and reached a unanimous decision to follow a path towards Open Access implementation that is independent of cOAlition S activities. Therefore it has decided to withdraw as a supporter of cOAlition S -> read more

Open Educational Resources. The Canadian Association of Research Libraries has issued a new call and set of resources on OERs. "As higher education continues to prioritize remote online instruction in the context of the COVID-19 pandemic, university libraries are working with others to advance, innovate and collaborate on the creation and use of high-quality open education resources. In recognition and support of the work of academic libraries, centres for teaching and learning, and faculty members leading the development of OER on campuses across the country and around the world, CARL's Open Education Working Group is pleased to share the following resources: an FAQ on Open Education, guidance for instructors on Getting Started with OER, and an Environmental Scan of Open Education Service and Support in Canada". -> read more

Canadian (CARL) Investments in Open Scholarship. The Canadian Association of Research Libraries (CARL) has released a report detailing its academic member institutions' financial contributions to the development and sustainability of the infrastructure and services that underlie open scholarship. One of the survey's main findings is that the total, aggregate spending on open by the 28 responding libraries during the 2018-2019 fiscal year was \$23 million CAD, with an average spend per institution of \$827,086. Individual libraries spent between 0.88% to 7.23% of their total budget on open scholarship (average of 3.09%). -> read more
