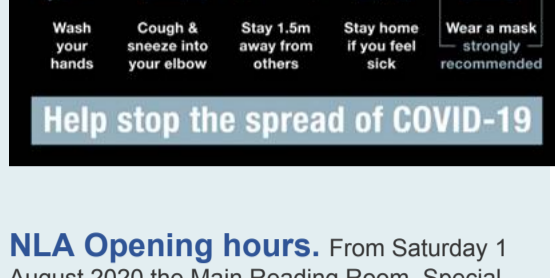

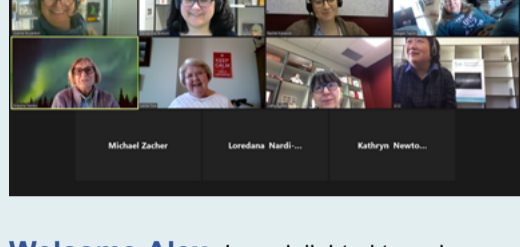

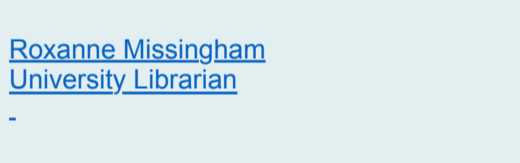

The Australian Society of Authors is working with the University of Melbourne and Australian public libraries on a pilot project to "breathe new life into important out-of-print Australian books by digitising them, licensing them into public libraries for digital lending, and making them available for sale as ebooks". This project is being led by Associate Professor Rebecca Giblin of the Melbourne Law School, with Dr Paul Crosby (Macquarie University), Professor Imke Reimers (Northeastern University) and Dr Airlie Lawson (University of Melbourne)

EU – privacy and trust.

- EU Commission's White Paper on AI – the European approach to excellence and trust EDPS has released its views on the White Paper. The EDPS recommendations in this opinion aim at clarifying and, where necessary, further developing the safeguards and controls with respect to protection of personal data.
On 16 July 2020, the European Court of Justice invalidated its previous Decision (2016/1250) and the EU-US Privacy Shield, which enabled certified companies to transfer personal data between the EU and the US. The case was brought by Max Schrems (the founder of NYOB) an Austrian resident, who had lodged a complaint with the Irish privacy regulator that the transfer of his Facebook data from Facebook's servers in Ireland to the US did not provide sufficient protection against access by the US public authorities. The Court found that, based on the use and access by US public authorities and surveillance programmes, interfered with the fundamental right of persons whose data is transferred to the US. However, the Court also determined that the Commission Decision 2010/87 on standard contractual clauses for the transfer of personal data to processors established in third countries is valid

E-Textbook Licensing Challenging. Many in the US have found that commercial publishers refusing to sell them e-textbook licenses for course reserves. The University of Guelph Libraries, Grand Valley State University Libraries, and the 23 California State University Libraries are among those who issued statements alerting campus stakeholders that they are unable to obtain copies of many textbooks in any other format than print, which means that students will have no alternative means of accessing their required course material. As publishers are seeking to set up programs that automatically bill each student directly for e-textbooks, libraries are working with faculty to find alternatives, including open educational resources and leveraging digital materials in the library collection.

Tweeting-Citations Authors Speak, Finally. Finally the authors of the rebutted report speak out "The real damage of this paper is not the promotion of a sham intervention, but to the reputation of the journal and the editors who are entrusted to run it. Yes, this is a time for professional discourse. The authors either need to admit error and retract their paper or provide evidence to support their claims."

Open Research

Modelling Overlay Peer Review Processes with Linked Data Notifications. Prepared by Paul Walk (COAR/ Antleaf), Martin Klein (Los Alamos National Laboratory), Herbert Van de Sompel (DANS) and Kathleen Shearer, this proposal presents a simple model using widely adopted technologies and protocols for exchange between services, and builds on previous work undertaken through the COAR Next Generation Repository Initiative and the Pubfair Framework to define new roles, technologies, and behaviours for repositories. Public comments on this model are sought until September 11, 2020.

"FAIRsFAIR" Project Seeks Community Input. The project is an initiative designed to provide practical solutions to help make repository content more findable, accessible, interoperable and reusable (FAIR). The project, launched in 2019, documented a set of "good practices" for repositories to use, and has now issued a call for comments on a set of recommended actions to help repositories to adopt and implement them. The recommendations focus on supporting FAIR data provision, improved handling and integration of metadata, and an increased emphasis on stewardship to ensure data remains FAIR in the long term. Based in Europe, its ultimate aim is to contribute to a set of global standards for FAIR certification of repositories. Feedback is due by August 21.

OAIC: notifiable data breaches. The OAIC's NDB statistics for January to June 2020 show a slight fall in the number of eligible breaches reported (518) against the previous six-month period (532), although there has been a 16% increase compared to the same period last year. Australian Information Commissioner and Privacy Commissioner Angelene Falk said malicious or criminal attacks including cyber incidents remain the leading cause of data breaches involving personal information in Australia.

Open Pedagogy Approaches: Faculty, Library, and Student Collaborations. This new book from Alexis Clifton and Kimberly Davies Hoffman contains a wide range of case studies. In April 2018, Open Pedagogy champion Robin DeRosa introduced faculty, librarians, and graduate students at the University of Rochester to two different concepts—open educational resources and open pedagogy. Open educational resources or OER are free online educational content licensed to allow users "permission to retain, reuse, revise, remix, and redistribute the material." Open pedagogy or OP is classically defined as an instructional approach that engages students in using, reusing, revising, remixing and redistributing open content. This book is meant to serve educators with varying levels of "open" experience and knowledge, whether one is starting small with a single assignment, radically revamping one's course design, or simply interested in learning about new pedagogical approaches.

COVID-19: Australian news and misinformation. Sora Park, Caroline Fisher, Jee Young Lee and Kieran McGuinness at the University of Canberra have published a fascinating report. Extracts: Most Australians are concerned about the COVID-19 outbreak. 60% say they are either very or extremely concerned about the coronavirus, 32% are somewhat concerned, and 8% are not very or not at all concerned. Concern is driving news consumption...Overall, Australians are accessing more news than usual...Australians have turned to TV news during social isolation...News coverage is impacting on people's wellbeing...Government is doing a good job of informing the public, but the news and social media exaggerate. Australians trust scientists and health experts the most as sources of information about the coronavirus... Australian government and news media perform better than in the UK and US...The majority did not come across misinformation about coronavirus...Social media is the main source of misinformation...Concern about COVID-19 drives verification.
