

### **COVID 19**

#### From ANU

Spatial distancing is still important to prevent the spread of COVID-19. Where possible, all people should stay approximately 1.5 metres apart from others.

However, in accordance with ACT Health guidelines, it is COVID-safe to have up to one person per two square metres (1 per 2m2) in buildings where 'Check In CBR' QR Codes are displayed.

In these circumstances, people may be slightly closer than 1.5metres but this is deemed to be low risk given the current risk levels in the ACT.

Our Public Health Directive on Venue Capacities has been updated to reflect this.

### ANU Press and Open Access Publishing

# University presses and the impact of COVID-19 by Charles Watkinson. Key points from the article:

- The COVID-19 pandemic will test the resilience of university press publishers because it is posing unprecedented pressures on their parent institutions, as well as affecting key markets for sales.
- Presses that have invested in digital technologies are recognizing the value of short-run digital printing and ebook distribution.
- Positive reactions to the temporary freeto-read programmes that many university presses put in place early in the pandemic have increased interest in sustainable open-access approaches among participating presses.
- Economic pressures have led to an increasing emphasis on the interdependent way in which the network of university presses provides vital infrastructure for humanities research.
- Differentiating concepts such as 'missiondriven' and 'values-based' are becoming more clearly articulated.
- University-based publishers have become energized by the opportunity to openly advance anti-racism and promote equity, justice, and inclusion.

#### Accessible Publishing in Australia.

Dr Agata Mrva-Montoya from Sydney University Press has shared the results of research into Accessible Publishing in Australia, conducted with two target groups in 2020 - a report and a snapshot are out now. The first survey collected information from staff engaged in publishing activity regarding the key drivers and challenges to transitioning workflows to create "born-accessible" books. It found promising trends towards the implementation of accessibility. The second survey collected information from staff at Australian disability service organisations and universitybased disability services units about the process of conversion of books into accessible formats. The respondents suggested several areas for improvement to make the conversion process easier and ensure faster access to books for individuals with print disabilities.

The AAAS has <u>updated its OA policy</u> to permit authors funded by cOAlition S funders to place a CC-BY or CC-BY-ND license on their accepted manuscripts to facilitate compliance with Plan S author rights retention policy. No fees and a trial! Open Access and Global South: It is More Than a Matter of Inclusion. From Haseeb Irfanullah suggests there is complexity that is glossed over in talking of the "global south", rankings are biased against these nations, Gold OA is not sufficient and publishers from the Global south must be included in the change.



#### Web updates

The Functions on Campus Protocol has been updated to include the requirement for organisers of events for between 201 and 500 people to notify ACT Health and <u>submit their</u> <u>COVID Safe plan via an online form</u>, as well as submitting a Functions on Campus eForm. Events over 500 will need an exemption in accordance with the COVID Safe Event Protocol, via the same form.







#### Higher education and the pandemic:

**key trends to watch in 2021.** An article in Times Higher Ed notes in relation to preprints: At the start of the pandemic, the use of preprints to disseminate research on Covid-19 exploded as scientists around the world scrambled to get a handle on the virus and its societal implications... According to the data, about 400,000 preprint articles were published in 2020, an increase of 47 per cent on the year before. Although 39,000 of these were classified as Covid-related papers, this still meant non-Covid preprints grew by a third, a rate of increase that was higher than the previous two years.

 Libraries and consortia are re-assessing big deals to determine their value.
 Librarians are evolving to deliver resources in a digital environment wherever possible.

## Transforming metadata into linked data to improve digital collection

**discoverability**. The OCLC **report** describes the results of the OCLC partnership with institutions that manage their digital collections with OCLC's CONTENTdm service to investigate methods for—and the feasibility of—transforming metadata into linked data to improve the discoverability and management of digitized cultural materials and their descriptions. In summary it found that Linked data can be used to add contextual information and to create a network of connections that better reflects knowledge in the real world.
