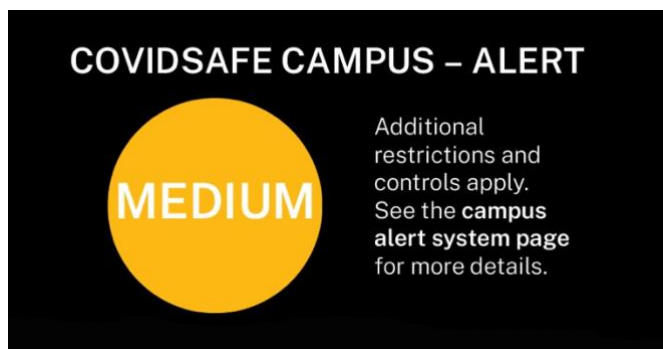
Masks

REALM research

OCLC has released a [research briefing](#) that describes how leaders strategically adapted to meet evolving needs and expectations as movements toward a **New Model Library**. Among the key takeaways:

- **Train for the future:** cross-training and upskilling were noted as valuable. Prioritise time and resources needed for staff's continued professional development.
- **Prioritise resources that close the digital divide:** the sudden shift to an almost entirely virtual world exacerbated and highlighted digital divide inequities, prompting changes in policies and ways of providing access to resources, instruction, and technology.
- **Partner with a purpose:** expanding partnership networks has helped leaders respond to emerging community needs and create engagement opportunities with a wider reach.

ANU Archives annual lecture

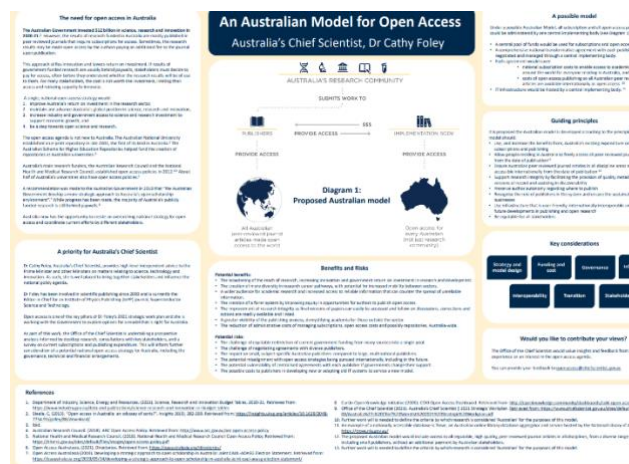

Academic Quality Assurance Committee (AQAC)

A very significant agenda for the last meeting of the year. In addition to a very large number of undergraduate award and

released in September includes responses from a worldwide sample of 1,843 college and university libraries.

The results show that academic libraries are undergoing swift and deep-reaching changes, particularly in areas affected by technology and changing user needs.

- Budgets lead library challenges.
- Increase in remote students.
- Cataloguing – need better tools, some will reduce some stay the same.
- Challenges related to ILL include high costs related to borrowing, and turnaround time for requests, E-resources have also changed the game.
- Affordable learning, efforts to reduce costs for students, especially around textbooks is being led by the library (think OERs).

The Lighting the Way Handbook: Case Studies, Guidelines, and Emergent Futures for Archival Discovery and Delivery

A great new resource – it is a synthesis of the work of participants in the [Lighting the Way Working Meeting](#), a practitioner-focused strategic thinking opportunity intended to explore topics related to archival discovery and delivery. It includes case studies, as well as chapters on assessing and applying standards and best practices, and emergent opportunities.



Digital Crossroads: The Intersection of Competition Law and Data Privacy

[This report](#) was written for the Global Privacy Assembly (GPA) Digital Citizen and Consumer Working Group. It seeks to identify and understand the interactions between antitrust and data privacy law around the world, drawing on the public perspectives of the agencies who enforce each area of law. It is based on a review of over 200 agency-related documents, including the relevant law, policy reports, guidance, speeches, market studies and litigation filings from numerous jurisdictions.

Copyright

- U.S. development: The Librarian of Congress has [issued new exemptions](#) to the prohibition on the circumvention of technological protection measures set forth in the 17 U.S.C. 1201. The librarian granted several of the exemptions—and expansions of existing modifications—requested by the Library Copyright Alliance (LCA) along with other parties. The new exemptions permit libraries, archives, and museums to circumvent the technological protections on DVDs in their collections for the purpose of preservation; and researchers to circumvent the technological protections on DVDs and eBooks for the purpose of text and data-mining
- NZ: the Government has agreed to extend the term of copyright for another 20 years. Libraries [foresee](#) this having a significant impact on their sector.
- U.S.: [State Sovereign Immunity Study](#). The U.S. Copyright Office published a full report on its State Sovereign Immunity Study, announced in the wake of the U.S. Supreme Court's decision in *Allen v. Cooper*. The Report

services and large online platforms. The Attorney-General's Department has also released a [discussion paper](#) for consultation as part of its current [review of the Privacy Act](#).

Scholarly Publishing – The Facts

The latest edition of the STM Report – [STM Global Brief 2021 – Economics and market size](#) – provides an update on the size and shape of scholarly publishing. Key findings include:

- it's big (\$28 billion in 2019), contracting in 2020, ready to expand again.
- yearly growth in articles of 4% and 5% in journals
- SSH journals and online content continued to grow at compound annual growth rates of 1.7% and 3.8% respectively
- Open Access publishing is growing much faster than the underlying market with revenues projected to increase at 11.5% and output at 12.5% (compound annual growth rates) from 2019-2022.

ProQuest and Clarivate merger

The Scholarly Publishing and Academic Resources Coalition (SPARC) filed comments with the U.S. Federal Trade Commission (FTC) [opposing the merger between ProQuest and Clarivate](#).

Top 10 IT Issues, 2022: The Higher Education We Deserve

Susan Grajek and the 2021–2022 EDUCAUSE IT Issues Panel find the top 10 IT issues for 2022 are:

- **Cyber Everywhere! Are We Prepared?:** developing processes and controls, institutional infrastructure, and

concludes that “there is ‘little justification for immunizing’ state actors, favors legislative recourse to allow damages to proceed against states, and notes that there is clearly evidence of state actor infringement, it also finds that the evidence submitted may not be sufficiently abundant or reliable to support constitutional abrogation legislation under Allen”.

Librarian Futures: Charting librarian patron behaviours and relationships in the networked digital age?

[This report](#) takes data from a survey of approximately 4,000 librarians and library patrons, interviews and other studies. Key findings:

- The knowledge gap is: from patrons, of the full extent of librarian support available to them; from librarians, of the emerging needs of their patrons and the new or enhanced areas of service provision these suggest
- 79% of faculty and 74% of students now begin their discovery process outside the library. Subsequent patron use, and appreciation for, library services, resources and the librarian remains high
- Patrons need library support - 88% of patrons would install an application for their library that sits within their workflow.
