ANU Press and open access

Strategic Monograph Publishing in the Humanities and Social Sciences in Australia

Agata Mrva-Montoy has researched this important issue, finding participants shared a remarkably consistent understanding of prestige in scholarly book publishing, despite the diversity of disciplinary and institutional backgrounds.

Invariably, university presses in the Global North were regarded higher than global commercial publishers, which in turn were seen as more reputable than Australia-based university presses and publishers. She finds that imposing a faculty-wide list of prestige publishers is counterproductive and can be harmful. A very important article.

Copyright

- The Commonwealth Government released the Exposure Draft of the Copyright Amendment (Access Reforms) Bill 2021. APA calls it "Unwanted gifts: Government copyright reform". Library and university groups welcome it. The Government is also reviewing the technological protection measure exceptions in the Copyright Regulations. A media release from the Hon Paul Fletcher MP is available along with a discussion paper. For more information, please see the Department's website. Responses to the draft are due by 5pm (AEDT) Friday 11 February 2022
- From the <u>Association of Research Libraries (ARL)</u>:
 The US Copyright Office is conducting a study of current copyright protections for publishers, and how

This report analyses how the scholarly communication system – involving the production, evaluation, and dissemination of research outputs – has responded to this crisis, focusing on the period until mid-2021. It evaluates ways in which the scholarly communication system, including its quality control mechanisms, has operated during the pandemic. It also examines how the global crisis has enabled innovations in scholarly communication, and the effects they have had on the system, or may have in future.

Reasonable terms of eBooks rejected

New York Governor Kathy Hochul vetoed legislation that would require publishers to offer licenses for electronic books to libraries under reasonable terms (S2890B / A5837B). The bills had passed the New York State Senate and Assembly with overwhelming bipartisan support in June 2021. ALA President Patricia "Patty" Wong issued the following statement:

"Governor Hochul's decision to veto S2890B / A5837B is unfortunate and disappointing. Protecting New Yorkers' access to digital books through the library is critical to ensuring equitable access to information for all. We are grateful to the New York Library Association and New York Library workers, advocates, and partners in the legislature who helped develop and champion this bill, and we will continue to work toward a solution that puts equitable access first".

Two million articles and counting!

arXiv.org now hosts more than 2 million articles.

arXiv, stewarded by Cornell Tech, is a free resource for scholars around the world in fields including physics, math and computer science, who use the service to share their own cutting-edge research and read work submitted by others.

"These 2 million submissions represent 2 million opportunities for humanity to push forward the frontiers of our understanding," said Tara Holm, Professor of Mathematics in the Cornell University

potential ancillary copyright protections for publishers might interact with current copyright law, particularly as it relates to news content. On 9 December 2021, the Copyright Office held a <u>public roundtable</u> <u>discussion</u> on these issues. Three takeaways from the roundtable are below.

- 1) There is agreement that high-quality journalism—particularly local journalism—must be sustained, but no consensus on a solution.
- 2) The US copyright regime prioritizes creativity and dissemination of knowledge.
- 3) Laws implemented in the EU and Australia must be considered in the US context. (Australia's News Media Bargaining Code)
- Ex Libris' goal is to enable libraries to incorporate
 <u>Controlled Digital Lending (CDL) into their workflows</u>
 if they choose to do so. CDL allows libraries to cater to patrons with differing needs and gives them the option to borrow books in a way which suits them.
- The National Library of Australia has released a list of out-of-copyright works for 2022, with most works now available to use freely without permission or restriction. Items in the public domain this year include unpublished works by authors who died in 1951, orphan works (i.e., works with no known author) created in 1951, and government publications created in 1971.

A shipment of around 500 books was received last week in the Chifley Library from Casalini.





MOU for access to records to support the Territories Stolen Generation

Last week we signed the Memorandum of Understanding in relation to access to records to support claimants of the <u>Territories Stolen Generations Redress Scheme</u> [from 24 January 2022 to 30 June 2026] between National Indigenous Australians Agency (NIAA) and the Australian National University.

Kathryn Dan has been working on this with ACT Records and NIAA. The is a very important commitment from the University to assist in support for the scheme designed to address harm and ongoing trauma by assisting with healing of trauma for Stolen Generations survivors removed in the Northern Territory (NT) or the Australian Capital Territory (ACT) prior to their respective self-government, or in the Jervis Bay Territory. An important initiative!

Aboriginal and Torres Strait Islander cultural precinct

The precinct will include a learning centre; a national resting place to care for Indigenous ancestral remains; and a new home for the Australian Institute of Aboriginal and Torres Strait Islander Studies (AIATSIS).

Keeping up to date

Facilitating and Illuminating Emergent Futures for Archival Discovery and Delivery: The Final Report of the Lighting the Way Project

Between September 2019 and August 2021, Stanford University Libraries facilitated *Lighting the Way: illuminating the future of discovery and delivery for archives*, with support from the Institute of Museum and Library Services.

Project participants also contributed a set of ten chapters to <u>The Lighting the Way Handbook</u>, an edited volume including case studies, analysis of how standards and best practices impact archival discovery and delivery, and emergent opportunities that amplify existing efforts.

Four recommendations are made to sustain the work undertaken and to inform the evolution of archival discovery and delivery that require investment and practitioners to step into leadership roles:

- 1. Develop new communities of practice that work in alignment with existing ones.
- Prioritize collaborative opportunities for strategy that explore new working relationships.
- Adopt and apply generative and carefocused facilitation methods to inform strategic planning.
- Understand the resourcing required and value the labor necessary to undertake strategic opportunities.

National Survey on Aboriginal and Torres Strait islander employment in Australian libraries: research report

This report provides outcomes of the research project National Survey on Aboriginal and Torres Strait Islander Employment in Australian Libraries conducted in the period of 2020 to 2021. The research aimed to find out more about the numbers of Aboriginal and Torres Strait Islander people employed in Australian libraries and identify the current employment types across a range of library settings.

The authors have been able to identify the trends in current employment roles; identify gaps; and understand more about the experiences of Indigenous people working in these libraries.

The research has shown there are unique opportunities for the library sector to support the work of Aboriginal and Torres Strait Islander people in Australian libraries and develop new pathways for current staff to access leadership roles and others to enter the profession. It has also identified significant gaps in support in this area and provided recommendations for future action and research.

Library of Congress Digital Collections Strategy

For the last five years, in accordance with their <u>Digital Collecting Plan</u>, the Library of Congress (LoC) has worked to make digital collecting a more Welcome back.

Trove Researcher Platform consultation to continue in 2022

The <u>Trove Research Platform project</u>, part of the <u>Humanities Arts and Social Sciences (HASS)</u>

OECD workshop on Al and the productivity of science

The OECD project on "AI and the Productivity of Science" addressed the critically important issue of the rate of scientific progress, whether this is stagnating, as recently argued by a number of scholars, and how AI could raise the pace of progress in science and discovery.

Audiovisual Metadata Platform Pilot Development (AMPPD) Final Project Report

The <u>final report</u> of this project reports on work carried out by partners Indiana University Libraries, AVP, University of Texas at Austin, and New York Public Library between 2018-2021.

"The overarching goal of the Audiovisual Metadata Platform Pilot Development (AMPPD) project, which took place from October 2018 through June 2021, was to develop enough of the AMP system to be able to pilot test it using two audiovisual (AV) collections from IU and a third collection from NYPL".

Based on work and results so far, the project team has concluded that the approach taken in AMP is effective and scalable for generation of metadata for certain types of AV collections, particularly those that involve significant amounts of spoken word content. This includes lectures, events, and documentaries, along with oral history interviews and other ethnographic content.
