Donation from Colin Steele

Following a suggestion from Friederike Schimmelpfennig, former University Librarian and Emeritus Fellow, Colin Steele, recently donated photographic albums and print items to the Butlin Archive, as well as a new short history, documenting the ANU Library's significant interaction with Chinese and Taiwanese libraries from 1980 to 2005, noting particularly the major contributions of Y.S Chan, Susan Prentice and Enid Bishop.

The donation includes the brochure produced in 1995 for a National Asian Information Centre, which was to be built on the ANU campus next to the Schools of Art and Music, to hold the joint collections of ANU and the NLA. Having passed through both Councils and major government budgeting processes, the funding was reallocated at the last minute by the personal intervention of Prime Minister Paul Keating for a major music centre in Melbourne. Copyright

The Commonwealth Government released the Exposure Draft of the [Copyright Amendment \(Access Reforms\) Bill 2021](#). Responses to the draft were due last week and the submissions should be live soon. ANU, ALIACC/ADA and CAUL submissions were all submitted on time.

You may have seen a [call for greater transparency by publishers](#) to publishers put out by cOAlition S this week. It was endorsed by International Alliance of Research Library Associations (IARLA), of which CAUL is a member.

Privacy

- The full bench of the Federal Court has ruled that the Australian Information Commissioner has leave to serve legal documents on Facebook Inc and Facebook Ireland in relation to serious and/or repeated interferences with privacy in contravention of Australian privacy law. The court rejected Facebook's appeal to set aside an earlier ruling by Justice Thawley of the Federal Court granting leave to the Commissioner to serve documents. The judgement is [here](#). Commissioner Falk [welcomed the decision](#) and said she was looking forward to the hearing of substantive matters. Structured around Data, Model Risk and Governance the report explores the various barriers to adoption, challenges and risks.
- The Bank of England and the Financial Conduct Authority launched the Artificial Intelligence Public-Private Forum (AIPPF) on 12 October 2020. The purpose was to further dialogue on AI innovation between the public and private sectors. The [final report is now available online](#).
- A full bench found that the University of New South Wales (UNSW) can publish its "myExperience" course surveys. [Read the Sydney Morning Herald article here](#).
- The Office of the Australian Information Commissioner (OAIC) has released its [Notifiable Data Breaches Report July to December 2021](#). Highlights: 464 notifications (up 6%); top industry sector health service providers; 71% of data breaches affected 100 or fewer people.

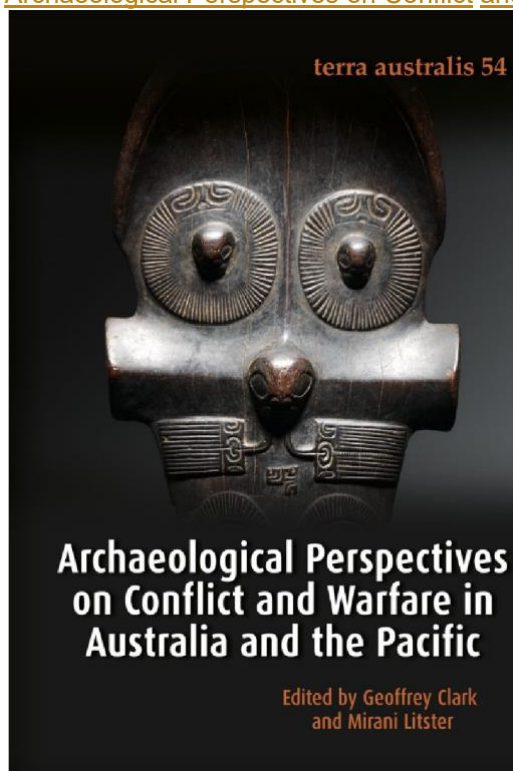

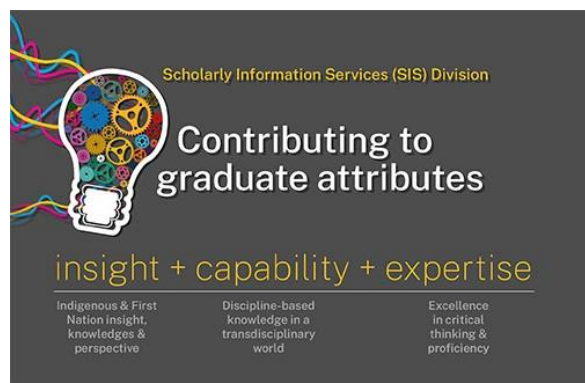
The Library Advisory Committee have expressed great interest in this area.

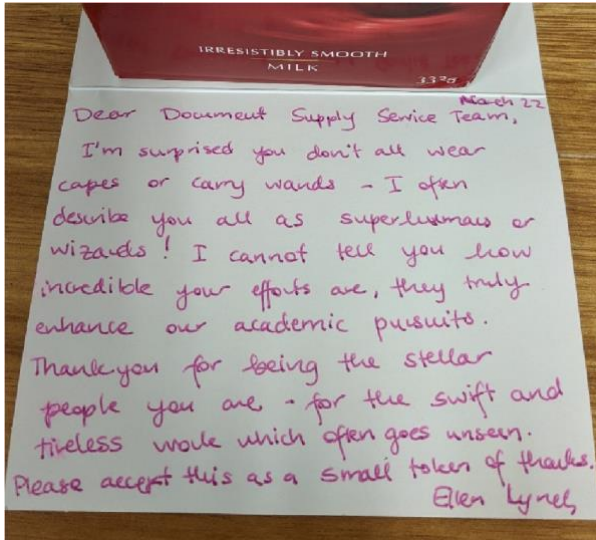

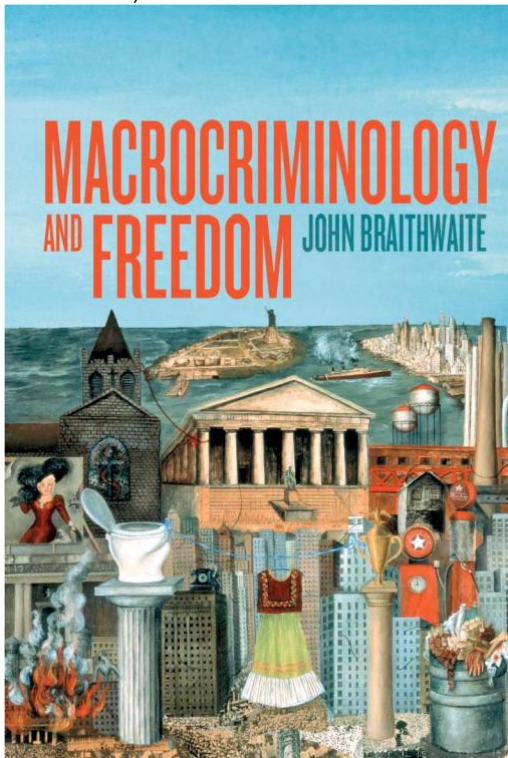

Open repository

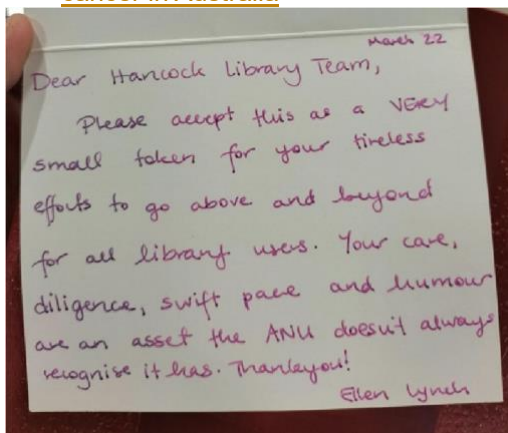
U.S. Repository Network initiative releases progress report

The U.S. Repository Network initiative is a partnership between COAR and SPARC aiming to catalyse a new U.S. network. The Visiting Program Officer for the U.S. Repository Network, Tina Baich, convened the Repository Expert Group and spoke with the COAPI and OpenCon Librarians communities between November 2021 and February 2022.

Teaching with cultural heritage materials during a pandemic: new report from Ithaka S+R

For those instructors who teach with cultural heritage materials, the shift to remote learning was even more complex. They had to discover new ways to incorporate archives, museum collections, special collections, and place-based learning within restricted learning environments.

Often, they had to contend with uneven levels of adequate technology while doing so. Through these challenges, instructors identified barriers to effectively teaching with cultural heritage materials remotely and learned to adapt.

In a [new report](#), Liam Sweeney and Kurtis Tanaka document those lessons. Instructors relied heavily on library and museum staff, archivists, and curators who, even as facilities were closed, took on the responsibility of digitizing materials and guest lecturing in remote classes. At the same time, instructors incorporated both open access and licensed digital heritage collections into their syllabi but often struggled with teaching students how to discover and use these resources. The pandemic has been disproportionately challenging for first generation, lower income, and minoritized students. Instructors also fear that remote learning has prevented their students from gaining important experiences within cultural institutions. Why do journals discontinue? A study of Australian ceased journals

[In this article](#), Hamid R. Jamali, Simon Wakeling and Alireza Abbasi have found that “the death age of journals was 19.7 (median = 16) with 57% being 10 years or older. About 54% of them belonged to educational institutions and 34% to non-profit organizations. In terms of subject, 75% of the journals belonged to social sciences, humanities and arts.

The survey showed that funding was an important reason for discontinuation, and lack of quality submission and lack of support from the owners of the journal also played a role.
