### Yumma Darruwa Ngunnawal

Welcome to Ngunnawal country. This fortnight I would like us to reflect on the word **Narragunnawali** which means *alive/well-being/coming together*. You may have seen this word on signs already, including in the [Peace Park](#) near the National Library.

If you have looked at the black granite square in the Canberra Peace Park and read the words on it you will have seen "Narragunnawali" written there. The polished black granite in the centre is sloped with the word 'Peace' etched into its panels in the six official languages of the United Nations Organisation and the Aboriginal language of the local Ngunnawal people. The UN languages are English, French, Spanish, Russian, Arabic and Chinese. At the heart of the feature is the international symbol of peace – an image of a dove carrying an olive branch – etched into the granite. ## ANU Press and open access

### Update on Trends in Open Access Publishing Released

Gold Open Access 2016-2021: Articles in Journals (GOA7), the seventh in a series of SPARC-funded studies of serious open access journals, is now available.

The analysis, performed by Walt Crawford through visits to each journal's website, indicates more than one 1.25 million articles in 2021. Gold (including no-fee or "diamond") OA varies widely. While 68% of journals that published articles in 2021 do not charge fees, 69% of the articles published in 2021 do involve fees.

The study is available in three forms, all with CC BY licenses. The free e-book and underlying dataset (both licensed under CC BY) can be found [here](#).

### Audiobooks 10 years of growth

Publishers' [audiobook revenue grew](#) 25% in 2021 to \$1.6 billion, which marks the tenth straight year of double-digit growth, according to the Audio Publishers Association's Sales Survey conducted by InterQ.

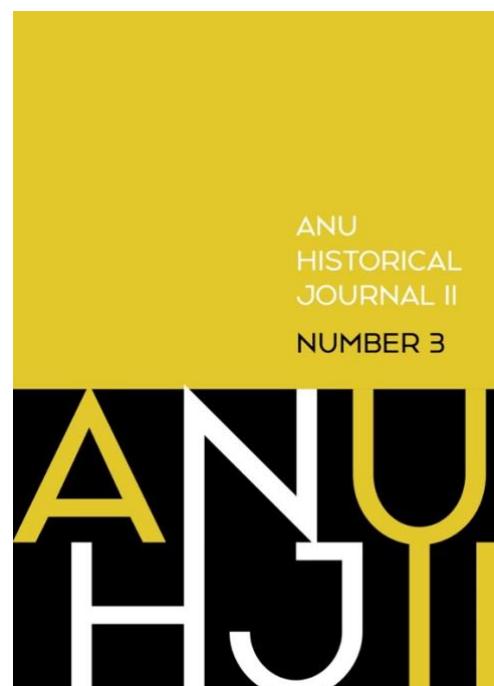

## Keeping up to date

### Custodians & Midwives: The Library of the Future

This [report](#) is the outcome of a research collaboration between the National Library of Australia (NLA) and new School of Cybernetics (SoCy) at the Australian National University (ANU).

During the collaboration, SoCy researchers investigated and evaluated the potential new dynamics that will emerge if, and when, the NLA integrates tools and processes enabled by promising artificial intelligence (AI) technology capabilities into core work processes of the organisation's mission to "collect, preserve and make accessible" library materials (National Library Act 1960 (Cth)).

## ANU policies

In preparation for the submission of the University's Tertiary Education Quality and Standards Agency (TEQSA) re-registration application in December 2022, the University is undertaking a review of all policy documents that are either due or overdue for review in order to meet the Higher Education Standards Framework (Threshold Standards) 2021.

As part of this process, the Corporate Governance and Risk Office (CGRO) recently reviewed and revised the Fraud and Corruption Control Policy and Procedure, initially approved by Council on 21 July 2017, and due for review by 30 June 2022. The proposed revisions are consistent with Go8 Universities' fraud policy and procedure, cover staff and students, and provide for enhanced reporting.

## New timetabling system

## CMU Receives NEH Grant To Develop Bibliographic Tools

The ISO has just released an Information Governance standard covering the concept and principles. Information Governance is defined as a strategic framework for managing information assets across an entire organisation to support its business outcomes and obtain assurance that the risks to its information, and thereby the operational capabilities and integrity of the organisation, are adequately identified and managed. Information Governance includes but is not limited to policies, processes, procedures, roles and controls put in place to meet regulatory, legal, risk and operational requirements.

The Queensland Office of the Information Commissioner hosted Professor Edward Santow to deliver this year's Privacy Awareness Week keynote. Professor Santow was joined by Queensland's Privacy Commissioner Paxton Booth.

Professor Santow discussed how in a time of unprecedented technological change, trust in government has been consistently falling. He challenged the audience to consider the use of Artificial Intelligence (AI), explore the rise of facial recognition technology and suggested a way forward that puts privacy at the heart of how AI is designed, developed and used, and how this could improve trust for agencies. ## Treventus ScanRobot 2.0 Robotic Scanner

After two years of planning and several COVID related delays, the Treventus ScanRobot 2.0 Robotic scanner is finally at its new home in Menzies Library.

The scanner is operational, however there is still work to be done with the Treventus team from Austria, in completing the set-up of the workflow that allows the post-processing and OCR of the scans to be more automated. A work around is currently in place.

The Canadian Association of Research Libraries (CARL) has released the [final Insights Report from its Diversity and Inclusion Study](#), prepared by the [Canadian Centre for Diversity and Inclusion](#) (CCDI Consulting).

In 2021, CARL conducted a Diversity and Inclusion Survey on behalf of 21 of its 31 member libraries. The survey was launched for anonymous participation on October 4, 2021 and ran until October 27, 2021. CARL conducted this study to gather baseline data on the composition of personnel in CARL libraries, gauge employee feedback on current EDI initiatives, and establish a set of benchmarks against which to evaluate and measure the impact of CARL libraries' strategies and practices with respect to diversity and inclusion. CARL aims to measure progress through the conduct of the same or a comparable study in 3-5 years' time.

## COAR Notify Project receives funding

The Confederation of Open Repositories (COAR) has been awarded a \$4 million grant from Arcadia to support the [COAR Notify Project](#) to develop and implement a standard protocol for connecting the content in the distributed repository network with peer reviews and assessments in external services, using linked data notifications.

The project will work across three dimensions: platforms and services, domain communities, and national/regional environments. The end result will be clusters of interrelated services that use the Notify Protocol to manage the interactions related to peer review on repository resources, and an open protocol that can be readily implemented by others for a variety of use cases.

This grant builds on years of work by COAR to enhance the role of repositories and transform scholarly communications, making it more research-centric, community-governed, and responsive to the diverse needs around the globe. SPARC is currently partnering with COAR on the development of a US Repository Network, and we look forward to promoting its work on Notify throughout our community

CODATA has launched a major new project: 'WorldFAIR: Global cooperation on FAIR data policy and practice', funded by the European Commission through its Horizon Europe Framework Programme. The project will work with a set of case studies to advance implementation of the FAIR data principles, in particular those for Interoperability, and to develop a set of recommendations and a framework for FAIR

## Streaming: Ithaka+ report

Ithaka S+R has released [public findings from the most comprehensive survey to date of academic library streaming media approaches at four-year institutions in the US and Canada](#).

The survey explored the range of vendors providing streaming media, acquisition models and licensing approaches, current and projected budgets, as well as libraries' own digitization activities. Findings include:

- *The impact on instruction* is the top factor driving academic library decision-making related to purchasing and renewing streaming licenses.
- *Streaming media is a growing segment of the library materials budget* and is projected to double over the next five years.
- Libraries are not investing heavily in *digitizing VHS tapes and DVDs*, relying instead on purchasing and licensing content to address demand.
- *Libraries in Canada and the US are taking a similar approach* to their streaming media strategies, with a major exception being the extent to which their strategies evolved in response to the pandemic.
