### ANU Press – diversity and inclusion

The Working Group on this issue met last week and came up with a range of very good suggestions.

### Humanities Commons Network to expand

Humanities Commons, an online open-source platform hosted and sustained by Michigan State University and used by thousands of humanities scholars and practitioners around the world, [was awarded a three-year, \\$1,249,282 grant](#) from the National Science Foundation to establish a Commons that focuses on STEM.

### US – new guidance from the Office of Science and Technology Policy

The big news of the fortnight - White House Office of Science & Technology Policy (OSTP) [issued an updated memorandum](#), “Ensuring Free, Immediate, and Equitable Access to Federally Funded Research.”

The memo calls on federal agencies to make “articles resulting from all U.S. federally funded research freely available and publicly accessible by default in agency-designated repositories without any embargo or delay after publication.”

It eliminates the 12-month embargo period and make articles—and the underlying data needed to validate results—openly available in machine readable formats. SPARC's [memorandum](#) provides very clear insights.

### Report on OA from the NZ Office of Prime Minister's Chief Science Advisor

Dr Tom Saunders' report [The Future is Open](#) is now available.

“This report offers recommendations for Aotearoa New Zealand's public research funders to improve access to publicly funded research. It is the result of a three-month science policy internship in the office of Professor Dame Juliet Gerrard, the Prime Minister's Chief Science Advisor, commencing in June 2021.

These recommendations, and the accompanying background material, are informed by a review of literature, and consultations with domestic and international stakeholders including

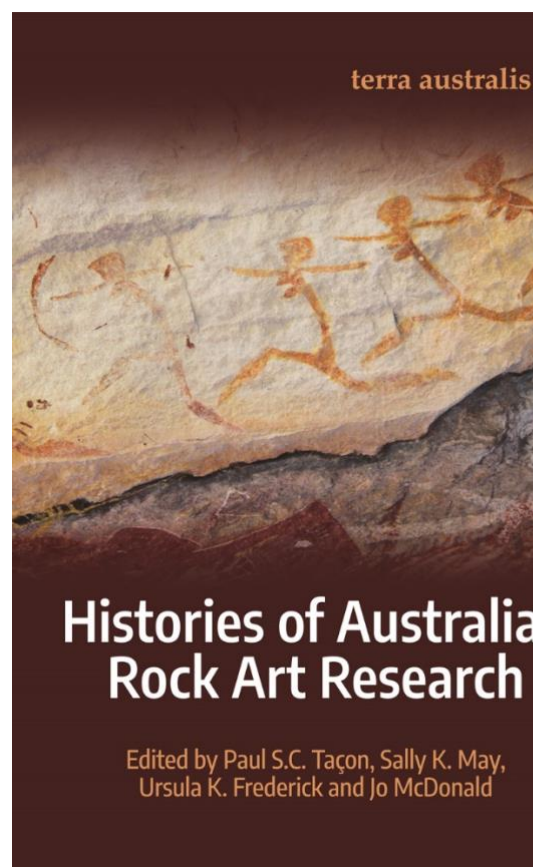

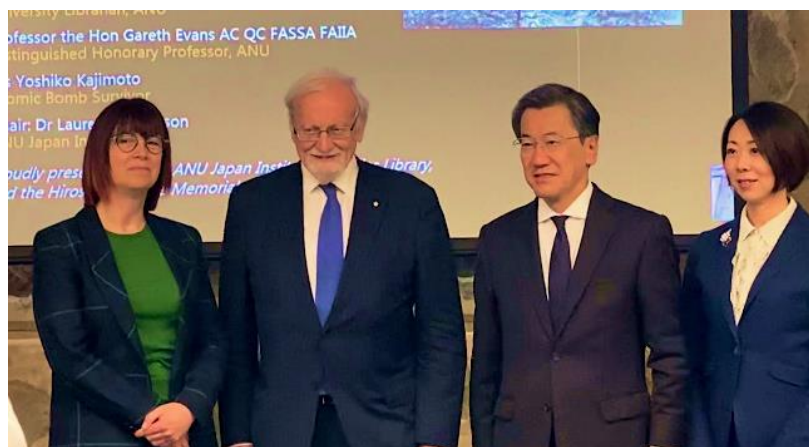
## Hiroshima exhibition in Menzies Library

The launch included a presentation from a Hiroshima survivor and a fabulous speech by former ANU Chancellor Gareth Evans on the need for better policy approaches internationally to nuclear bombs.

### ARC and ERA

Education Minister Jason Clare has announced a review to advise whether the “role and purpose” of the Australian Research Council (ARC) remains relevant, its operating model is “fit for purpose” and consider how it can meet current and future needs and maintain the trust of the research sector.

The Minister has also asked ARC: “in light of the sector’s concerns about workload, I ask that you discontinue preparations for the 2023 Excellence in Research for Australia (ERA) round and commence work to develop a transition plan, in consultation with the sector and my Department.”

## Keeping up to date

Professor the Hon Gareth Evans AC QC FASSA FAIIA has donated his personal papers to the research collections of the ANU Archives, signing a Deed of Gift with University Librarian Roxanne Missingham and University Archivist, Kathryn Dan.

This extensive collection will be a major resource for researchers as it reflects Professor Evans' wide range of international engagements and leadership in foreign relations, human rights, conflict resolution and nuclear non-proliferation and disarmament, as well as his distinguished role as Chancellor of ANU.



## EU – a concerned look on the new copyright teaching exceptions

Eduardo Santos (Defesa dos Direitos Digitais and NOVA School of Law) commences his [review](#):

“With Article 5 of the [CDSM Directive](#), the EU legislator introduced a new mandatory copyright exception for the use of protected works for educational purposes.

The new exception is intended specifically for digital and cross-border teaching activities, something that gained major relevance also due to the outbreak of the COVID-19”.

Some key points:

- Hungary was the first Member State to implement Article 5 CDSM Directive, even before transposing the remainder of the Directive, as a response to new and urgent digital teaching needs during the COVID-19 pandemic.
- The German transposition of Article 5 generously exercised the margin of discretion for the licensing option left to national legislators by the EU Directive. According to the authors, the German transposition is likely to benefit end-users, compared to the InfoSoc-inspired teaching exception.

## Archivists Survey

The findings from the Ithaka S+R study [A\\*CENSUS II: All Archivists Survey](#) are out.

It was the first national survey in 17 years designed to gather information about the demographics, education levels, job placement, salaries, and student loan debt of archivists and community memory workers. The survey also explored the extent to which this community views the archival profession as inclusive, equitable, and diverse.

Nearly 6,000 archivists took the time to share their experiences through the survey, resulting in a comprehensive portrait of the profession.

Thanks to F&S and Construction Control for the update on the hail remediation work on Chifley, Law and Menzies Libraries. Much more to come soon. In summary:

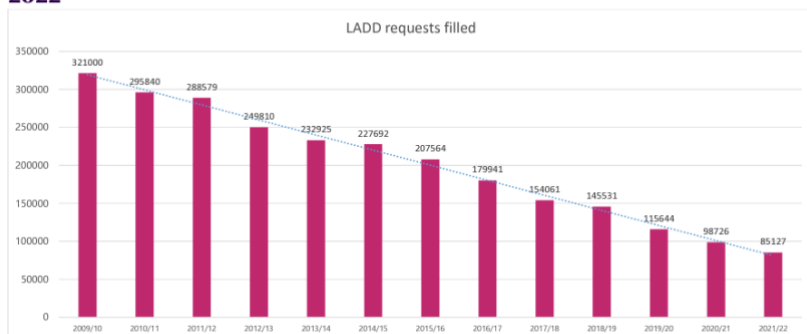
- Chifley work is pending approval but likely that scaffolding will go up in around 2 - 3 weeks with 4 weeks to install period. Then the work commences on the roof.
- Law – current and next steps include tenders and design work.
- Menzies roof will require additional assessment and approvals.

- The MLS/MLIS degree has risen in importance while also being more likely to result in student loan debt.
- The proportion of BIPOC individuals in the archives profession has doubled since the last survey in 2004.
- One in five respondents are considering leaving the archives profession within the next five years.

Additionally, the survey results point to the challenges community archives face: a lack of funding, storage space, and awareness of their collections.
