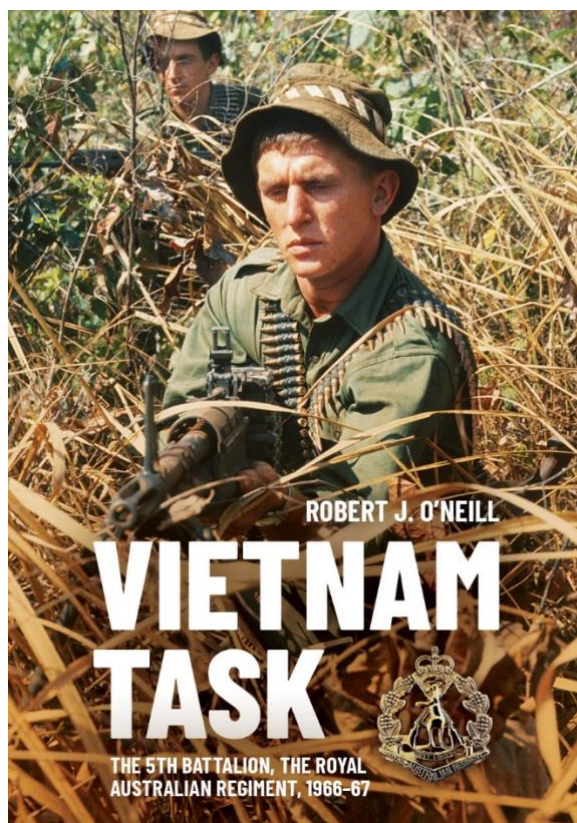

## ANU COVID-19

**The rules around masks at ANU have changed now.**

Here is the [message from the VC](#):

**It will continue to be mandatory to wear a mask in classrooms until the end of this semester** to ensure our students and teaching staff can confidently continue to come to campus and participate in person.

You must also wear a mask in a clinical setting. Masks are still recommended, and I encourage everyone to be respectful of colleagues, students or visitors who may wish to wear a mask - so keep one with you just in case. We will monitor COVID's progression and will not hesitate to bring back a full mask mandate on campus if we see rises in severe COVID cases within our community.

**Please remember to isolate and get tested if you feel unwell.**

It's important that you let us know if you test positive for COVID-19. ## Open repository

**Public access data management and sharing activities for academic administration and researchers**

[The Realities of Academic Data Sharing \(RADS\)](#) Initiative's public-access data management and sharing (DMS) activities are the result of categorizing services and support across the institution that are likely needed to make public access to research data available.

The RADS project team categorized these activities by life-cycle phases for public access to research data, and used the activities in RADS surveys of publicly funded campus researchers and institutional administrators whose departments likely provide support in these areas.

This report presents version 1 of the RADS public access DMS activities. Additional versions are expected to be released as more institutions

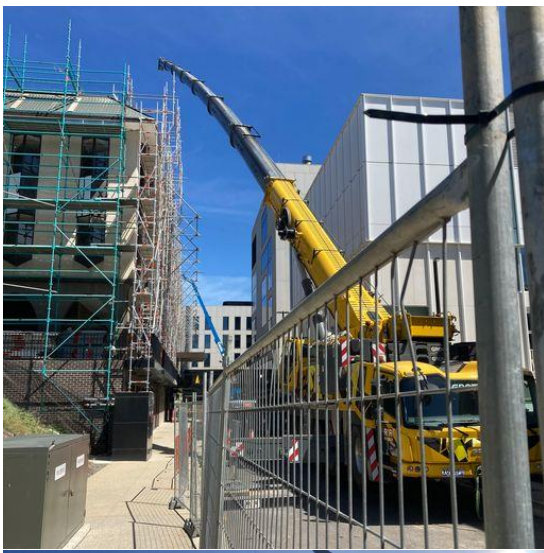

### Association of Research Libraries (ARL) releases report on U.S. academic member libraries' open infrastructure expense

From ARL: In May–June 2022 the Association of Research Libraries (ARL) surveyed its US-based academic research libraries to better understand OA expenses. The survey asked respondents to categorize expenses into six areas of investment: read-and-publish or transitional agreements, article processing charges (APC) or OA funds, non-APC-based OA publishing models, institutional repository services, OA journal hosting and publishing services, and open monographs. This [ARL report](#) provides a summary and analysis of the aggregate data from the survey, provides charts on institutional responses and averages, and discusses some outcomes and next steps. ## Copyright

- The hearing before the Federal Court of the application for judicial review has been deferred.
- Protecting Australian artists: new review - Attorney-General's Department [will release an issues paper](#) for public consultation as the first stage of a review into whether Australia's current copyright enforcement regime is fit-for-purpose.
- Attorney-General, the Hon Mark Dreyfus KC MP, has announced that the Australian Government will shortly commence a [review of Australia's copyright enforcement regime](#). This review will consider whether the copyright enforcement mechanisms in our laws remain appropriate, effective and proportionate.
- Copyright licensing 01: Navigating the Copyright Tribunal. Timothy Webb and Francesca Teng from Clayton Utz have written a very useful [statement](#) that commences "The Copyright Tribunal's determination in the Isentia matter, upheld by the Full Federal Court, sets a clear precedent for the Tribunal both as to its statutory task and the boundaries of its power to set licence terms". "In this first of two articles, we describe the key Australian collecting societies and the rights they administer, the role of the Copyright Tribunal in relation to collective voluntary licences, and who can make an application to the Tribunal. We also discuss the critical stages of Isentia's application to the Copyright Tribunal and the outcome of each. In part two, we will examine the Full Federal Court's decision in CAL's application for judicial review and identify some key strategic matters to consider in copyright licence negotiations."
